



STWNA General Meeting Minutes – Wednesday 1/14/09

Welcome and introductions- President Heather Sutton welcomed members and Board members and all introduced themselves.

Invited guest speakers – Police Dept Reps – both San Jose and Campbell policed Dept reps were not able to attend the meeting.

The agenda was approved after amending to move the election to last under organizational business.

Board Reports:

Heather Sutton, President – Leadership update –

San Jose Council member, Pete Constant wants residents to know they are surveying issues of interest. End of January there will be a budget priority workshop. Feedback from the public is welcome.

The current property owner is cleaning up former dry cleaning store contaminants. Then Robson can finalize purchase of property and seek approval from city council. Robson will get back to us on results.

Mervyn's property owners are looking into options for new tenant. Redevelopment is possible, but city would prefer commercial/retail.

Organizational Business

Bylaw Amendments – President Heather Sutton explained the changes being proposed to the STWNA Bylaws. Article IV, Officers, Sections 1, 2, 3, 5, 8H and Section 9

Article IV, Officers, Section 1 (composition) ...and Immediate Past President which shall automatically be filled by the outgoing President.

Article IV, Officers, Section 3 **A) An office on the STWNA Executive Board may be filled by either one (1) or two (2) people in the role of Co-Officers**

Article IV, Officers, Section 5 (Term of Office)...**Exception: The term of office for the Immediate Past President shall be one (1) year and begin immediately following the election of a new President.**

Article IV, Officers, Section 8 **H) Immediate Past President: The Immediate Past President shall serve as an advisor to the President and Executive Board during a leadership transition.**

Article IV, Officers, **Section 9 (Co-Officers)**

- A) In the event that an office is filled by two (2) people in the role of Co-Officers, the duties of that office will be shared accordingly.**
- B) B) In the event that an office is filled by two (2) people in the role of Co-Officers, each party is eligible to cast a one half (1/2) vote during executive board meetings. If only one party is present he/she is eligible to cast one (1) full vote during executive board meetings.**
- C) C) In the event that an office is filled by two (2) people in the role of Co-Officers, and one party resigns or becomes ineligible to hold office, the remaining party shall fulfill all duties pertaining to the office until a replacement appointment is made or the end of his or her term.**

Question: Why to have 2 co-presidents? To divide the time commitment.

Lisa Riggs (1st VP) and Peter Rushbrook (nominee) spoke about the co-chair issue and how it came about.

It was suggested that the Immediate Past President serve as a Non-Voting Executive Board member – Motion was to approve the bylaw amendments, including language for a Non-voting Immediate Past President.. All bylaw changes were voted on and approved by members present as amended.

2009 Priorities Master Plan

Members were given a few minutes to review the proposed Master Plan and ask questions.

It was explained that Dumpster Day would probably be smaller scale than last time, less dumpsters, due to the smaller budget.

National Night Out –Aug 4 –community night to get neighbors together to discuss safety concerns, etc

2009 Master Plan voted on and approved.

2009 Calendar

December event will switch to a Wednesday evening instead of Saturday, due to the busy time of year.
